

LOCATION

The Old Goods Yard is located on the southern outskirts of Lenham, a small market village in the Maidstone borough of Kent. It is positioned approximately midway between Ashford and Maidstone and around 6 miles south-east of the M20 motorway. Lenham railway station provides services to central London (Victoria and St Pancras) with journey times of around 1 hour 15 minutes.

The property is adjacent to Lenham railway station and situated at the end of an unadopted road leading from Headcorn Road, which runs parallel with the railway line.



DESCRIPTION

The property comprises a mainly concrete surfaced, open storage yard having chain link perimeter fencing and a gated entrance from Headcorn Road

TERMS

The property is available to let on new lease for a term to be agreed.

RENT

£40,000 per annum exclusive.

DEPOSIT

A deposit equivalent to 3 months' rent will be held by the landlord for the duration of the term.

BUSINESS RATES

The tenant will be responsible for the payment of business rates, with the Rateable Value (RV) from April 2023 being:
